Does HMC have Ulama within its board committee?

Does HMC consider non-HMC certified meat and poultry to be Haram?

No. We do not comment on non-HMC certified products. We can only say that they are not certified by HMC as they do not meet our standards or have not been monitored.

Help us protect Halal in the UK

Muslims in the UK have been legally allowed to consume Halal meat/poultry that has been religiously slaughtered for decades. With 90% of animals being stunned that may not conform to the Halal standard, the government are now trying to introduce measures to reduce the amount of non-stunned Halal being done in the UK. We therefore call for the entire community to support this campaign to protect Halal in the UK for generations to come.

Muslims are commanded by Allah SWT to eat food which is permissible i.e., Halal. With the reduction of non-stunned Halal being produced here in the UK, this may lead to a complete ban as we have seen in other European countries. With 70% of Muslims wanting to consume meat/poultry that is non-stunned, the availability on the other hand of non-stunned Halal is less than 10%. We understand that the Muslim community will continue to eat meat and poultry, however, we wish to ascertain your support so that we can protect Halal food provision in the UK for generations to come.
